Conversion costs for the school to switch from propane to natural gas were discussed. It was also discussed that a Survey for the residents in town is needed and then another town hall meeting will be set up after the results of the survey come back. No action taken.

The quote for RV outlets at the Rodeo grounds was discussed. Adrianne Luthi will have Jeff Scheele call Ward Stockamp about a few questions and Ward will report back. The Burt's are to drop off their plan at the city office. The council will read their proposal and vote on it at the August 12th meeting.

The flood map was discussed. Adrianne Luthi will put something in the newsletter regarding the proposed changes that are being looked at for the flood plain area in the city.

The disk golf course that Chris Rose with the Rec is handling was discussed. Ward updated the council that Chris told him that they are getting closer to needing holes dug and setting poles.
