Donna Polich with Bennington Saloon and Chad Blackwood with GR Parkers asked for approval of special event permits for the street dance after the rodeo on June 4th and for the streets to be blocked off from 8:00 pm to 1:00 am, serving liquor from 5pm to 12 am. Motion by Brian Davidson, second by Judith Swagerty to shut the street down between Washington and Bennington streets from 8 pm to 1 am and to allow alcohol to be served 5 pm to midnight and to approve both permits. Motion Carried.

The email received regarding new Oil Slurry prices from South Central Paving was discussed. The council said the increase of \$3187.60 for oil was fine to add to our bill for the street paving project.

The property at 316 N. Lincoln was discussed. Council discussed and are ready to proceed with legal action letters to get this taken care of.
