Motion Dennis Kelley, Second by Brian Davidson to bring the revenue neutral rate hearing to order at 7:00 p.m. Motion Carried.

Roll Call for the Revenue Neutral Rate hearing was completed. Voting yes were: David Galvan, Brian Davidson, Laura Bowers and Dennis Kelley. No Vote was received from Judith Swagerty who was absent.

Motion by David Galvan, second by Brian Davidson to adopt Resolution 2022-07 to levy a property tax rate exceeding the revenue neutral rate. Motion Carried.

Additions to the agenda were: Fire Hydrants, Cameras for pool area, David Galvan's resignation and safety audit for Kansas Department of Labor.

Motion by David Galvan, second by Dennis Kelley to approve the August 8th 2022 meeting minutes and the printed list of bills. Motion Carried.

Present at the meeting were Mayor Ward Stockamp, David Galvan, Brian Davidson, Laura Bowers and Dennis Kelley. Amy Stevens was also present. There were no visitors.

Council discussed buying four new hydrants, tabled until next meeting. No action taken.

Cameras for the pool area were discussed. David Galvan presented several options to the council. Motion by Laura Bowers, second by Brian Davidson to approve purchase of a four camera system for \$1749.99. Motion Carried.

David Galvan presented his resignation to the council because he is moving out of the city limits of Bennington. Motion by Laura Bowers, second by Brian Davidson to accept David Galvan's resignation effective 08/22/2022. Motion Carried.

Ward Stockamp discussed the process of the safety audit being done by KDOL on August 23rd.

Brian Davidson asked the council for \$750.00 to offset the cost of removing the dilapidated house at 113 South Lincoln street. Motion by David Galvan died for lack of a second.
